10. DESCRIPTION/JUSTIFICATION OF AMENDMENT, MODIFICATION, OR CHANGE ORDER: The contract provides financial assistance to the county solely for the expenses necessary to answer 911 calls originating in the county, which includes performing certain tasks and maintaining certain equipment necessary to operate Wireline and Wireless Enhanced 911. Reimbursement shall be solely for eligible items included in Chapter 118-66 WAC. The original contract Budget sheet was based on estimated expenditures. Through the Mid-Year Review process, counties have determined more accurate expenditure amounts. This amendment is necessary to adjust the funding in the Budget sheet (Exhibit C) and the contract period based on updated expenditures projected from 6 months worth of actual expenditures.			
11. AMENDMENT TERMS AND CONDITIONS: <ol style="list-style-type: none"> Contract expiration date of September 30, 2008 remains unchanged. Change the overall contract amount from \$298,975 to \$290,819; a decrease of \$8,156. In the Budget Sheet, Exhibit C, State Reimbursable column, make the following changes: <ol style="list-style-type: none"> Wireline change from \$97,390 to \$96,817; a decrease of \$573. Wireless change from \$201,585 to \$194,002; a decrease of \$7,583. <p>No other changes are required. All other terms and conditions of the original contract and any previous amendments thereto remain in full force and effect.</p>
