PUBLIC HEARING LEVYING TAXES FOR 2007 BUDGET AUDITOR

At approximately 3:00 p.m. **CHAIRMAN BOWEN** opened a public hearing to consider levying taxes for municipal purposes of Kittitas County, Washington for the year 2007 according to the assessed valuation as determined in the year 2006.
