- **PAYMENT TO SUB-CONTRACTORS:** The Sub-contractor/s shall be paid by HopeSource upon 100% completion of the job as specified on the Scope of Work and when all the terms of the agreement between the Sub-Contractor and HopeSource are met.
- **INDEMNIFICATION:** I hereby release and pledge to hold harmless HopeSource and its staff from any liability in connection with the work listed in the Scope of Work or any act or eventuality arising from this work. I agree, and do hereby indemnify, hold harmless and defend, HopeSource, Housing Improvement & Preservation Program (HIP), the Washington State Department of Commerce, Kittitas County, USDA, and the U.S. Dept. of Housing and Urban Development, their agents, servants, or employees, from and against any and all claims for injuries or damage to persons or property of whatsoever kind or character.
- **OWNER/S' COOPERATION:** Owner/s shall permit Sub-contractor(s) and HopeSource to use, at no cost, existing facilities on the premises including, but not limited to, light, electricity, and water which are necessary to carry out the completion of work under this Contract. Owner/s shall cooperate with Sub-contractor/s and HopeSource to facilitate the performance of work in all reasonable ways including, but not limited to, the removal of rugs, coverings, furniture, and appliances, as necessary. Owner shall make all reasonable attempts to accommodate the schedule of HopeSource staff and contractors while weatherization work is being done on the home.
