BACKGROUND:

The County Road Administration Board (CRAB) provides state funding for road improvements projects on a bi-annual basis. The 2013-2015 project applications were awarded by the County Road

Administration Board in April 2013.

Public Works submitted a grant proposal for road improvements to No 6 Road. Previously, the safety enhancement project was awarded \$146,500 in June 2013. The funding obligated by CRAB for this project will be increased to \$1,347,000. We are currently negotiating with an engineering consultant to provide design services. We will not be reimbursed for construction until April 2016. Engineering design is expected be complete this year.

These improvements will provide safety enhancements to the road. To maintain public health and safety, it is necessary for these road

improvements to meet traffic demands.
