3,407.76	Tie in necessary monumentation to calculate property and right of way locations (24 hrs. @ \$141.99/hr.)
34,645.56	Field locates for right of way survey and topographic map for design (244 hrs. @ \$141.99/hr.)
3,816.72	Drawing times for right of way survey (36 hrs. @ \$106.02/hr.)
9,329.76	Drawing times for topographic map (88 hrs. @ \$106.02/hr.)
12,039.72	Professional Land Surveyor professional times for checks and certification of all work (84 hrs. @ \$143.33/hr.)
\$ 66,931.26	Total costs
