**AGENDA DATE:** March 16, 2010

**ACTION REQUESTED:** Approve and sign the County Road Project for Carroll Road bridge replacement.

---

**BACKGROUND:** The bridge located at Mile Post 0.58 on Carroll Road exhibits severe damage to the concrete superstructure. The bridge was originally built in 1932 and rebuilt in 1955. The proposed bridge will provide additional structural confidence for the anticipated traffic. The bridge will also be widened from 20 feet to 24 feet for Road Standards compliance. Coordination with the Cascade Canal will continue through construction.

The project is described on the 2010 annual construction plan. Grant funds are not available for this project due to the functional classification of the road. Public Works will fund this project.

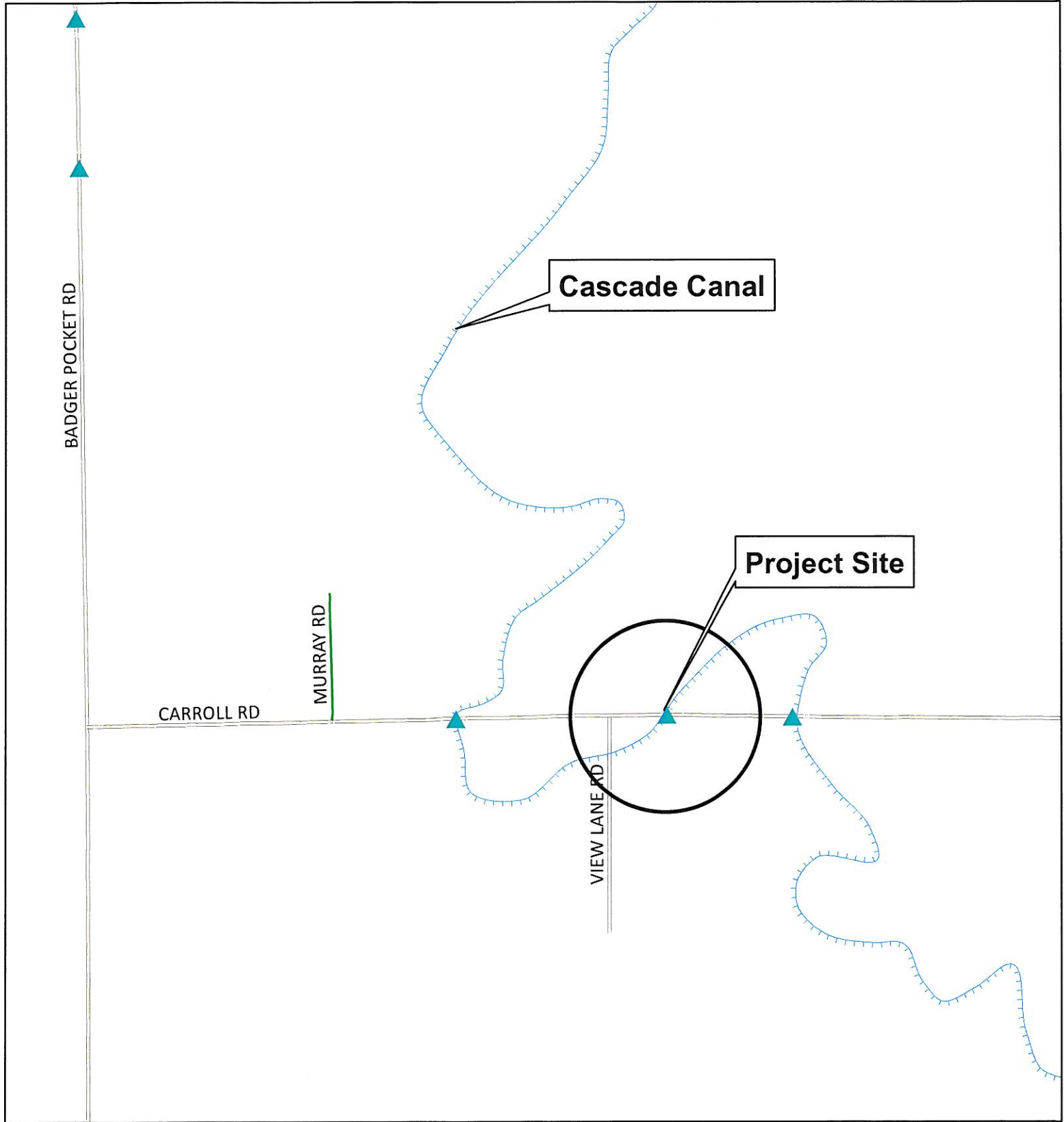
