



This Amendment is made by the state of Washington, Department of Corrections, hereinafter referred to as Department, and Kittitas County, hereinafter referred to as the County, for the purpose of amending the above-referenced Contract, heretofore entered into between the Department and the County.

WHEREAS the purpose of this contract amendment is to amend the terms;

NOW THEREFORE, in consideration of the terms and conditions contained herein, or attached and incorporated and made a part hereof, the Department and County agree as follows:

Section 1.16-**Offender Day** is amended as follows:

Section 1.16 - Offender Day – an Offender Day is any day a Department Offender is in the custody of the County including the first day the Offender is delivered to the County. An Offender Day ends at midnight of the day immediately preceding the day of the Offender's release or return to the custody of the Department. An offender day shall not include any day that is by state law the financial responsibility of any other jurisdiction. ~~((If there are one or more holds, in addition to the Department's, on a Department offender, the County shall bill the other jurisdictions for their proportionate share of the offender per diem. The Department's share will be determined by dividing the base rate by the number of jurisdictions with holds on the offender and the Department will be responsible only for its proportionate share of the base rate.))~~

Section 3.11- **Billing**, is amended, in part, as follows:

"Section 3.11 **Billing**. The base rate will be sixty (\$60.00) dollars per day per Upon execution of this Amendment 1, the daily rate shall be sixty one dollars and eighty cents (\$61.80) for the term of this amendment. ... ~~((If there are one or more holds, in addition to the Department's, on a Department Offender, the County may bill the other jurisdictions for their proportionate share of the Department Offender per diem and medical costs. The Department's share will be determined by dividing the base rate as identified above by the number of jurisdictions with holds on the Department Offender and the Department will be responsible only for its proportionate share of that base rate.))"~~

Additions to this text are shown by underline and deletions by ((strikeout)). The effective date of this amendment is February 1, 2014, regardless of the date of signature.

All other terms and conditions contained in the Agreement and any amendments thereto shall remain in full force and effect.


