The contract provides financial assistance to the County solely for the expenses necessary to answer 911 calls originating in the county, which includes performing certain tasks and maintaining certain equipment necessary to operate Wireline and Wireless Enhanced 911. Reimbursement shall be solely for eligible items included in Chapter 118-66 WAC. This amendment is necessary to adjust the funding in the Budget sheet (Exhibit C) based on updated expenditures and projected revenues.

- 4. Change the FY14 Wireline funding amount from \$128,303 to \$137,834; an increase of \$9,531
- 5. Change the FY14 Wireless funding amount from \$153,965 to \$151,111; an decrease of \$2,854
- 6. Replace the original Budget sheet (Exhibit C) with the attached Revised Budget sheet (Exhibit C).
