To Revise the 2013-2016 Surface Transportation Program (STP) Federal Funds Prioritization for the Kittitas County Region

- WHEREAS: Federal Surface Transportation (STP) funds are allocated annually for distribution among the qualified transportation agencies within Kittitas County to improve local transportation facilities; and
- WHEREAS:Since 1991, Kittitas County has been authorized to program
federal STP funds within its region in cooperation with the
Washington State Department of Transportation (WSDOT); and
- WHEREAS: Kittitas County Public Works has developed a regional prioritization and selection process, cooperatively with a technical advisory committee made up of Public Works staff from local jurisdictions and in consultation with WSDOT, to allocate STP regional federal funds within its region; and
- WHEREAS: The STP technical advisory committee recommends that the Board of County Commissioners revise the priority order of projects as shown in Exhibit A; and

NOW, THEREFORE BE IT RESOLVED: The Board of County Commissioners, after due consideration, does hereby accept Kittitas County's STP technical review committee recommendations as presented in Exhibit A to revise the prioritization of projects to receive Surface Transportation Program (STP) federal funds, in accordance with WSDOT guidelines.
