The scope of this project includes widening the pavement from its existing width of 20 feet to 24 feet (11 foot lanes and 1 foot shoulders. The Bituminous Surface Treatment (BST) surface will be paved with Hot Mix Asphalt (HMA). The shoulders will be improved for stability


