Re: Easton Memorial Day Special Event Permit

Dear Ms. Kjorsvik:

Upon review of the above permit application, I have the following comments/requirements;

- A separate Event Permit is required from the Fire Marshal's Office. A fee of \$130.00 shall be submitted with the Fire Marshal's Office Event Permit application.
- Any vendor booths that have open flame for cooking shall have an approved fire extinguisher readily available.
- Any vendor booth which utilizes LPG tanks for cooking or heating shall have an approved fire
  extinguisher readily available. In addition, any LPG tank shall be secured to prevent
  displacement.
- Vendor booths shall be separated by a minimum of 10 feet between structures.
- Any stage erected for performances shall be inspected prior to use.
- Any enclosed area in which alcohol is to be served shall have exit signs, as appropriate, and may not have open flame devices within that area.
- The permit required from this office is not for the parade; rather it is for the vendor booths, stage, etc.

The intent of the International Fire Code is to provide a reasonable level of life safety and property protection from the hazards of fire, explosion or dangerous conditions. The requirements listed above offer a reasonable level of fire and life safety protection for this project. 
