**RESOLUTION TO AWARD THE BID TO FURNISH SNOW & ICE CONTROL  
PRODUCTS FOR 2015 AND AUTHORIZE THE PUBLIC WORKS DIRECTOR TO  
SIGN CONTRACT DOCUMENTS**

WHEREAS: A Notice of Call for Bids was approved and signed on November 4, 2014, to furnish Snow & Ice Control Products for 2015; and

WHEREAS: Sealed bids were opened on November 20, 2014, at 2:00 p.m. in the Kittitas County Public Works and two (2) bids were received; and

WHEREAS: The Public Works Department recommends that the responsible bid of Envirotech Services Inc. for Item #1 – Corrosion Inhibited Liquid Magnesium Chloride and Item #3 – Corrosion Inhibited Solid Sodium Chloride; and the responsible bid of Rankin Products LLC for Item #4 – Non-Corrosion Inhibited Solid Sodium Chloride be accepted for Snow & Ice Control Products for 2015; and

WHEREAS: Item #2 received no bids;

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners, in the best interest of the public, does hereby award the bid for 2015 Snow & Ice Control Products to Envirotech Services Inc. for Item #1 – Corrosion Inhibited Liquid Magnesium Chloride and Item #3 – Corrosion Inhibited Solid Sodium Chloride; and the responsible bid of Rankin Products LLC for Item #4 – Non-Corrosion Inhibited Solid Sodium Chloride be accepted for Snow & Ice Control Products for 2015, upon such terms and conditions as specified in the Proposal submitted by said bidder(s).

BE IT FURTHER RESOLVED that the Director of Public Works is authorized to sign the contract documents upon such terms and conditions specified in the Proposal submitted by said bidder(s).


