That the Undersigned, being of lawful age, for the sole consideration of six thousand four hundred and one dollars and fifty five cents (\$6,401.55), which the County has obligated itself to pay by warrant upon process of this release, do/does hereby and for my/our/its heirs, executors, administrators, successors and assigns release, acquit and forever discharge Kittitas County, its elected officials, officers, agents and employees acting on behalf of the county or in their individual capacities from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of service, expenses and compensation whatsoever, which the undersigned now has/have known or which may hereafter accrue on account of or in any way growing out of any and all known and unknown, foreseen and unforeseen bodily and personal injuries and property damage and the consequences thereof resulting or to result from the accident, casualty or event which occurred on or about the 4<sup>th</sup> day of March, 2014, at or near 190 Zrebiec Road in Cle Elum, WA.

It is understood and agreed that this settlement is the compromise of a doubtful and disputed claim, and that the payment made is not to be construed as an admission of liability on the part of the party or parties hereby released, and that said releases deny liability therefor and intend merely to avoid litigation and buy their peace.

The undersigned further declare and represent that no promise, inducement or agreement not herein expressed has been made to the undersigned, and that this Release contains the entire agreement between the parties hereto, and that the terms of this Release are contractual and not a mere recital.
