

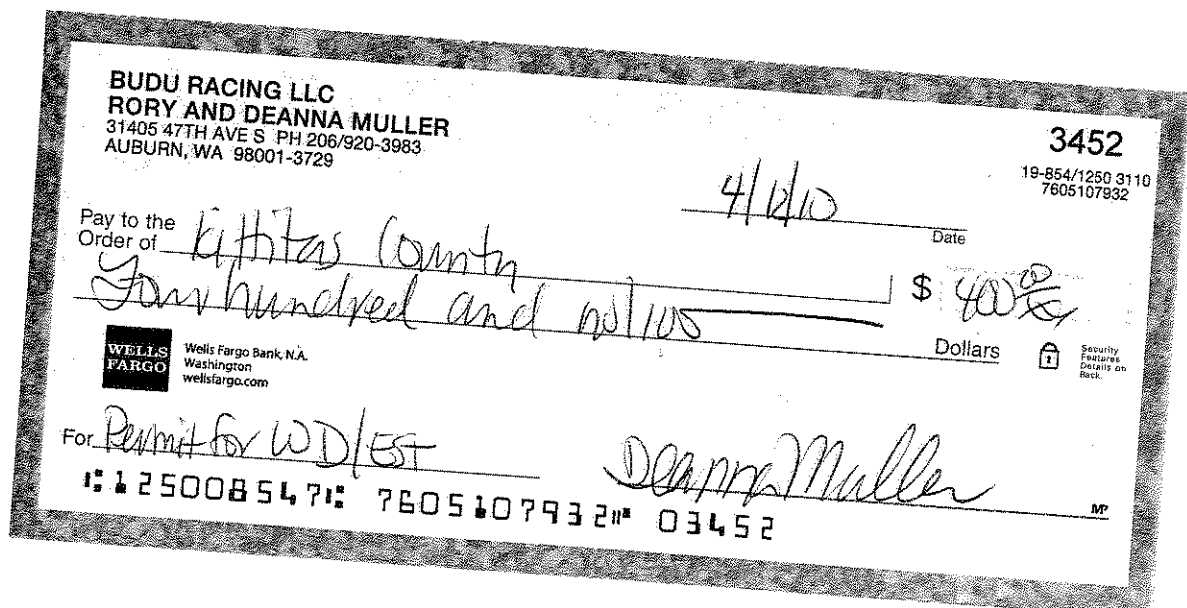

Dear County Commissioners:

The 27th Annual Whisky Dick Triathlon (promoted by BuDu Racing, Tami Walton, Craig Scrivner and Vince Nethery the Ellensburg Endurance Sports Association {EESA}) is scheduled this year for Sunday, August 1, 2010. We are also including the WD-10K Run, on Sunday morning that will utilize the same run course as the Whisky Dick Tri. The 2nd Annual Ellensburg Sprint Triathlon is anticipated to grow substantially and is on Saturday July 31. Both these events coincide with the Jazz in the Valley Festival weekend and we believe this will make the weekend more fun and bring more new faces to the great community of Ellensburg.

A primary outcome of the Triathlon weekend is the promotion of tourism in and businesses of Kittitas County. As you know, the triathlon has been a tremendous success over the past few years and we feel it is a great promotional event for the city.

Therefore, we formally request that Kittitas County permit us to hold the races again this year. The events do commence before 10am, so we request we be given approval to start at the times listed above. Also, we are requesting a waiver to the Penal Bond, as we do not believe that the runners, and cyclists will be causing damage to the roads and such that we are utilizing.

As per last year, **Whisky Dick Triathlon** requires use of the Kittitas County boat launch at Vantage for the swim to bike transition. The cyclist will ride on the Vantage Highway through to the fairgrounds in Ellensburg followed by a run out and back along the John Wayne Trail, down Pfenning Road, through Grasslands before returning to the fairgrounds via Capitol, Alder, Craig's Hill, and Chestnut.

In order to assist us in use of these facilities, we request that the County:

- Close the Kittitas County Boat launch at Vantage from 6:00 am until 10:30 am on August 1st
- Close the Vantage Highway from Vantage to No. 81 Road from 7:00 am until the last biker completes the course (approximately 11:30am) – Sheriff will monitor for traffic.
- Have the Director of Public Works facilitate the safety of the race by sweeping the bike route and boat launch of loose debris prior to the race and to schedule chip sealing of any of the aforementioned roads after August 1st. If chip sealing is not possible to delay, please schedule as early as possible in the summer so that a hard surface is well established by race day.

We also ask permission to use the portion of the Fairgrounds facilities as granted in all previous years, namely the entry gate area and adjoining grass areas behind Memorial Pool and have access to power from a pole on race day for the finish – awards activities and lunch. Restrooms are available at the city pool..

The **Ellensburg Sprint Triathlon** transitions in and out of Irene Rinehart Park with the swim in Carey Lake, the cycle encompassing Umptanum, Brondt, Brown, Hanson, Cove, and Manastash Rds., returning to Irene Rinehart Park. The run is within the Irene Rinehart and West Ellensburg Park boundaries.

The insurance certificate with Kittitas County listed as an additional insuree is attached.

The following information is provided for the county health office in anticipation of standard queries we receive from them each year:

1. All water for aid stations will be from the city water supply, not an out-of-town well.

2. Post-race food for Whisky Dick will consist of bagels, meats and cheese, fruits and muffins.
3. Pre-cooked pizza for Whisky Dick volunteers will be prepared by the Super One grocery deli on race day.
4. There will be 4 port-o-lets at Memorial Park (Whisky Dick finish) in addition to the restrooms at the pool. As well as additional port-o-lets at Irene Rinehart Park
5. There will be one dumpster at Memorial Park.

We thank you for your consideration. If you have any questions, or need more information, please do not hesitate to make contact with either of us by phone or email. We ask that you respond by email so that we can proceed accordingly and we thank you in anticipation.

As noted in the letter sent in early June:

Road safety: This year, the course is different as we are taking the cyclist straight on Vantage Highway into Ellensburg. Block and Man Vantage Highway to all but "Official Whisky Dick Vehicles" (from 7:00 am – until all athletes are off the bike course (~11:30) - a trail vehicle will follow the last competitor) at:

- The boat ramp at Vantage
- The junction of Rd. 81 and Vantage Hwy
- The junction of Parke Creek and Vantage (prevent circumventing Rd.81 block)

We are truly appreciative of your past support and know that the athletes are as well. If you have any questions, or need more information, please do not hesitate to contact me. We ask that you formally respond to confirm the aforementioned details by either standard mail or by email and we thank you in anticipation.

Will there be off-site Parking?

Parking will be at the Fairgrounds and surrounding streets. With an estimated attendance of 200, this should be enough parking.

Will there be shuttle buses provide for attendees?

Triathletes will board a bus at the Fairgrounds and take it to the Vantage Boat Ramp, leaving at 6:45am.

Will there be tickets sold to attend the event?

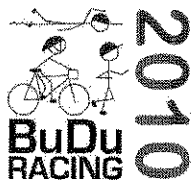

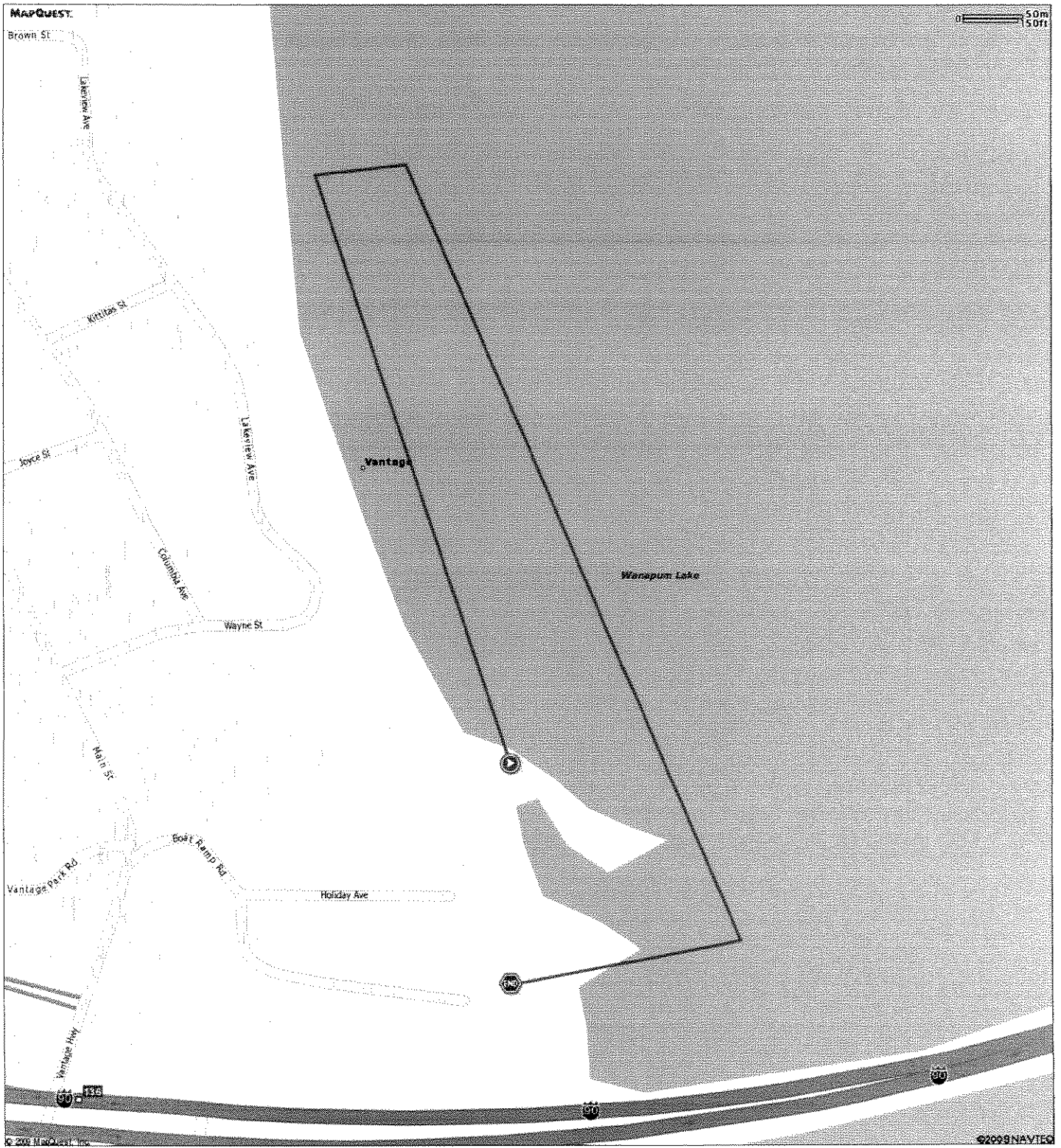

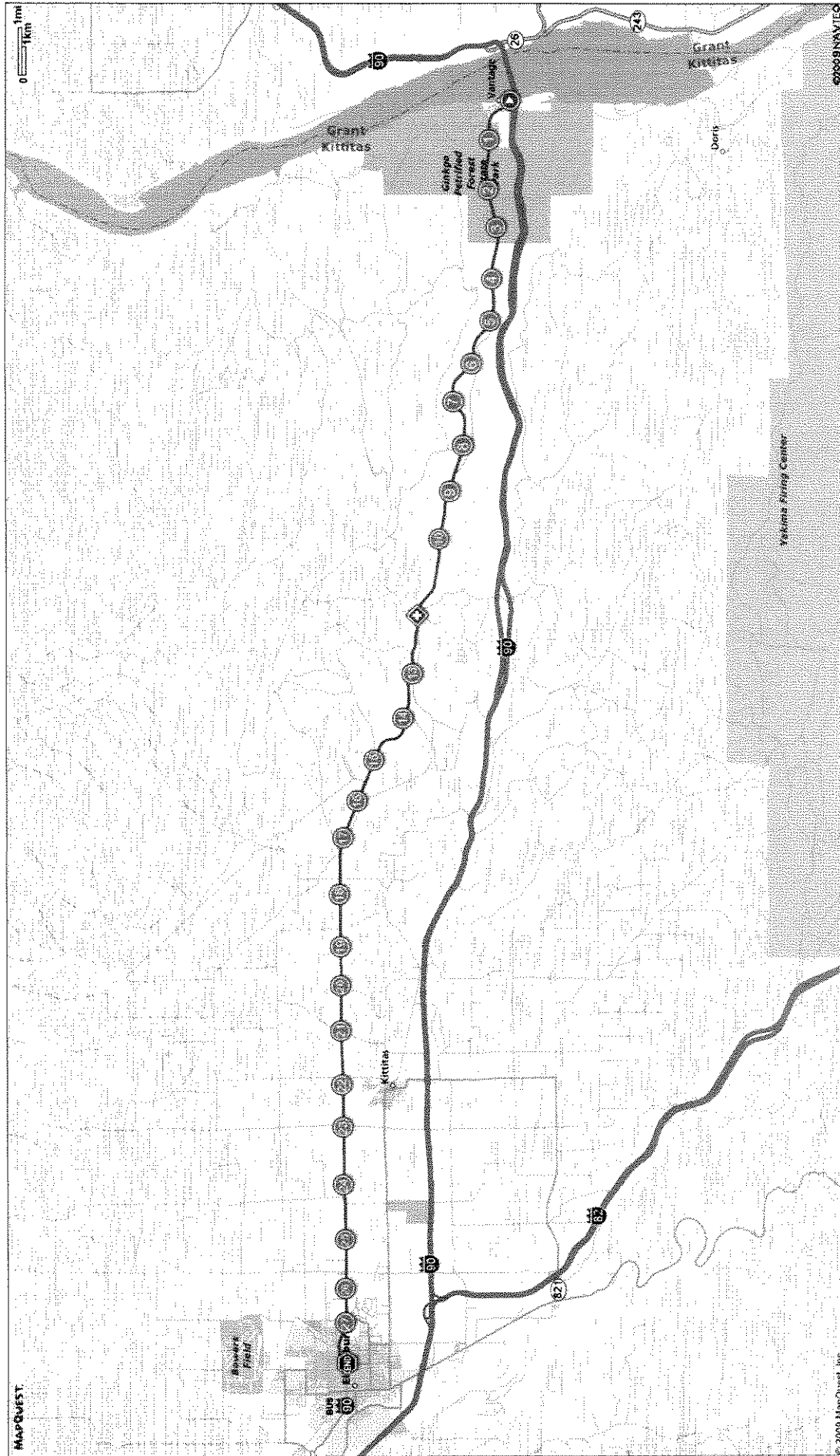
