**A Resolution Changing Authorized Cash Balances  
for  
Petty Cash, Revolving Funds, Till Accounts, Funds on Deposit, etc**

**WHEREAS,** The County Auditor is establishing a master list of all department and county fund petty cash custodians and petty cash dollar amounts; and

**WHEREAS,** the previous Resolution Number 2013-058 must be updated and rescinded due to changes in dollar amounts and personnel.

**WHEREAS,** this resolution increases the Treasurer Change fund by \$300; eliminates the authorization for the \$400 account for County Fair to be used for the *Ye Olde County Faire*; authorize the creation of Investigation Petty cash for Public Health in the amount of \$230 to be used for compliance checks which will be opened and closed for a short time period.
