**RESOLUTION No. 2015 - 098**

**WHEREAS**, RCW 39.34, the Interlocal Cooperation Act, provides the capability for public agencies to cooperate by providing services and facilities for mutual advantage; and

**WHEREAS**, on February 3, 2015, the Board of County Commissioners of Kittitas County, Washington authorized the execution of an interagency agreement between the Kittitas County Public Health Department (hereinafter "KCPHD") and the Washington State Department of Ecology (hereinafter "Ecology"); and

**WHEREAS**, the purpose of said interagency agreement is to provide funding to KCPHD for conducting an assessment to determine the effectiveness of outreach and education efforts related to air quality in Kittitas County; and

**WHEREAS**, KCPHD and Ecology wish to amend said interagency agreement to provide funds for two KCPHD staff members to receive training on community based social marketing; and

**WHEREAS**, Kittitas County and Ecology are agreeable to amendment of said interagency agreement under the terms and conditions of the amendment attached hereto; and

**WHEREAS**, the Board of County Commissioners of Kittitas County, Washington authorized the execution of this amendment by action taken at a regular meeting; and

**NOW THEREFORE, BE IT HEREBY RESOLVED** that the Board of County Commissioners of Kittitas County, Washington authorizes the Director of KCPHD to execute the amendment to the interagency agreement with Ecology that is attached hereto, and incorporated herein by this reference.

## **AMENDMENT NO. 01**

TO

INTERAGENCY AGREEMENT NO. C1500083

BETWEEN THE

STATE OF WASHINGTON DEPARTMENT OF ECOLOGY

AND

KITTITAS COUNTY PUBLIC HEALTH DEPARTMENT

**PURPOSE:** To amend the Agreement between the state of Washington, Department of Ecology, hereinafter referred to as "ECOLOGY," and Kittitas County Public Health Department, hereinafter referred to as "KCPHD" or "RECIPIENT."

**WHEREAS,** it is mutually agreed between ECOLOGY and KCPHD that in preparation for sustainable messaging, additional funds to send two staff members to the introductory and advanced training for Community Based Social Marketing is being added to this agreement.

**IT IS MUTUALLY AGREED** the Agreement is amended as follows:

- 1) Is amended to read as follows:

### **STATEMENT OF WORK**

KCPHD shall furnish the necessary personnel, equipment, material and/or service(s) and otherwise do all things necessary for or incidental to the performance of the work set forth in Appendix A, attached hereto and incorporated herein. In addition, KCPHD will furnish two staff members to attend training for Community Based Social Marketing and create and implement a curriculum to share information from the training with all staff.

- 2) Is amended to read as follows:

### **COMPENSATION**

Compensation for the, work provided and staff training, in accordance with this IAA has been established under the terms of RCW 39.34.130, and in accordance with Governor's Executive Order 10-07 and RCW 39.26.180(3). This is a performance-based contract, in which payment is based on the successful completion of expected deliverables. The parties have determined that the cost of accomplishing the work herein will not exceed ~~\$20,043.77~~ **\$26,524.71**. Payment for satisfactory performance of the work shall not exceed this amount unless the parties mutually agree to a higher amount. Compensation for services shall be based on the terms set forth in accordance with the tasks listed in Appendix A, Statement of Work and Budget, which is attached hereto and incorporated herein. ECOLOGY will not make payment until it has reviewed and accepted the completed work.

3) Is amended as follows (adding the following language to existing Appendix A):

Proposal Summary:

KCPHD's mission is to protect and promote the health and the environment of the people of Kittitas County. Health impacts from poor air quality in Kittitas County are a concern that falls within that mission.

In an effort to maintain outreach and continue efforts to avoid non-attainment the Community Based Marketing training will serve towards sustainable efforts on the part of the KCPHD in current and future sustainable air quality improvement efforts.

4) Is amended to as follows (adding the following language to existing Appendix A):

A. Project Work Plan (adding the following):

**Objective C:** By June, 30, 2015, KCPHD will attend Community Based Social Marketing introduction and advanced training to provide effective community outreach in continuing efforts to avoid non-attainment. Knowledge from the training will be disseminated to other Public Health Staff and the Air Quality Advisory Committee.

Activities	Deadline	Deliverable
<u>Task 1.</u> Select two KPHD employees to receive Ecology scholarships to attend training on Fostering Sustainable Behavior at the Community Level. Selected employees should be willing, able, and available to train others in the department upon return from class. Selected employees should be in a position to incorporate theory into practice upon returning from class. Selected employees must have support from their authorizing environment to conduct the activities.	May 30, 2015	Statement of which employees will be trained, how they meet the above criteria, and which training session they will attend.
<u>Task 2.</u> Train two KCPHD employees in Fostering Sustainable Behavior at the Community Level. The employees will attend the introductory and the advanced course in their entirety.	June 15, 2015	Certificates of Completion from Training Provider.
<u>Task 3.</u> Draft a plan for training others in the KCPHD and Air Quality Advisory Committee on the theories and content learned. The plan should include a schedule, a rough outline of content to be presented, and a description of personnel and departments to be trained.	June 30, 2015	Draft of Plan.
Deliver final report.	June 30, 2015	Final Report
