• Food Safety and Service to be provided by Paradise Rose Catering Co. Caterer must apply for permits at least 2 weeks prior to the event.

Since heat and maintaining cool food temperatures has been noted on past inspections, please have food set up in an area where shade is offered and there is covering over food service and prep areas.

Bathroom Facilities – compliance met with fixed facilities and additional port-a-potties (one for every 50 people).

To Whom It May Concern:

In regard to the above mentioned project, I have the following comments:

- An event permit is required from the Fire Marshal's Office. A site plan indicating parking area, concessions, bathrooms, etc., shall be provided to this office a minimum of two weeks prior to the event. The applicant needs to contact this office and schedule an inspection the week prior to the event. At the time of the inspection, any additional requirements will be noted and completed prior to the event.
- Fire extinguishers shall be located in each vendor unit, at the bleacher area and any other buildings in which the public will have entry.

The intent of the IFC is to provide a reasonable level of life safety and property protection from the hazards of fire, explosion or dangerous conditions. If you have further comments or questions, please do not hesitate to contact me at 509-962-7000.
