AFFIRMING THE APPEAL OF THE D&H RANCH, INC., SDL PROPERTIES, INC., AND L&D LAND CORPORATION, INC. SHORT PLATS.

- WHEREAS, Jeff Slothower as agent for D&H Ranch, Inc., SDL Properties, Inc. and L&D Land Corporation, Inc. filed an appeal regarding short plats SP-07-00160, SP-07-139, SP-07-148, SP-08-00051, and SP-08-53; and
- **WHEREAS**, the Kittitas County Board of County Commissioners, on May 25, 2010, held an open record hearing on the appeal during which testimony was taken and those wishing to speak on the matter were given such opportunity; and
- **WHEREAS**, the Kittitas County Board of County Commissioners closed the record and continued the matter until June 8, 2010 for deliberation; and
- **WHEREAS**, the Kittitas County Board of County Commissioners deliberated over the matter on June 8, 2010; and
- **WHEREAS**, after such deliberation, a motion was made, seconded and approved that all pending land use applications should be processed in accordance with Kittitas County Resolution 2004-36.

1. The appeal brought by Jeff Slothower on behalf of D&H Ranch, Inc., SDL Properties, Inc. and L&D Land Corporation involved the following short plats:

- 4. The Appellants' short plat applications that are the subject of this appeal currently pending before Kittitas County should be processed in accordance with Kittitas County Resolution 2004-36;
- 5. Based on the foregoing findings by the Board of County Commissioners, the appeal is granted and the Board of County Commissioners orders that that the Appellants' short plat applications be processed under Kittitas County resolution 2004-36.
