This agreement reflects a change to a Block Grant funding format for funding Juvenile Court Services Consolidated Contract Programs through the current State Fiscal Year 2011. This includes E3SHB funds in the amount of \$12,305 and an allotment of \$106,627 for Chemical Dependency Disposition Alternative (CDDA), Special Sex Offender Disposition Alternative (SSODA), Community Juvenile Accountability Act (CJAA), & Consolidated Juvenile Services Programs provided in Kittitas County. Additionally included in the Statement of Work are options of Suspended Disposition Alternative (SDA) & Mental Health Disposition Alternative (MHDA). Allocated funding for Kittitas County is detailed on the attached revised allotment spread sheet for County allocations.
