AGENDA DATE: December 1, 2015

ACTION REQUESTED: Approve County Road Project for North Ferguson Road Siphon Construction.

BACKGROUND: Kittitas County Conservation District (KCCD) is planning to replace a bridge on North Ferguson Road over Town Ditch and fish barrier irrigation diversion with a siphon and screened diversion. The existing bridge is in disrepair and in need of replacement. The anticipated cost to the county for bridge replacement is estimated to be approximately \$350,000 as a stand-alone project. The project as proposed by KCCD will include the replacement of this bridge with a siphon. Kittitas County Public Works is planning to expend \$85,000 to this project for a significant savings to the road fund. Total construction cost is estimated to be \$1,077,040.80.

The project will be formally added to the 2015 annual construction plan through the adoption process. The project will be paid using \$85,000 of county road funds once KCCD funds for the siphon and associated appurtenances are expended.



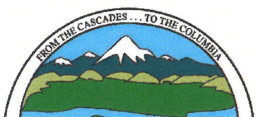
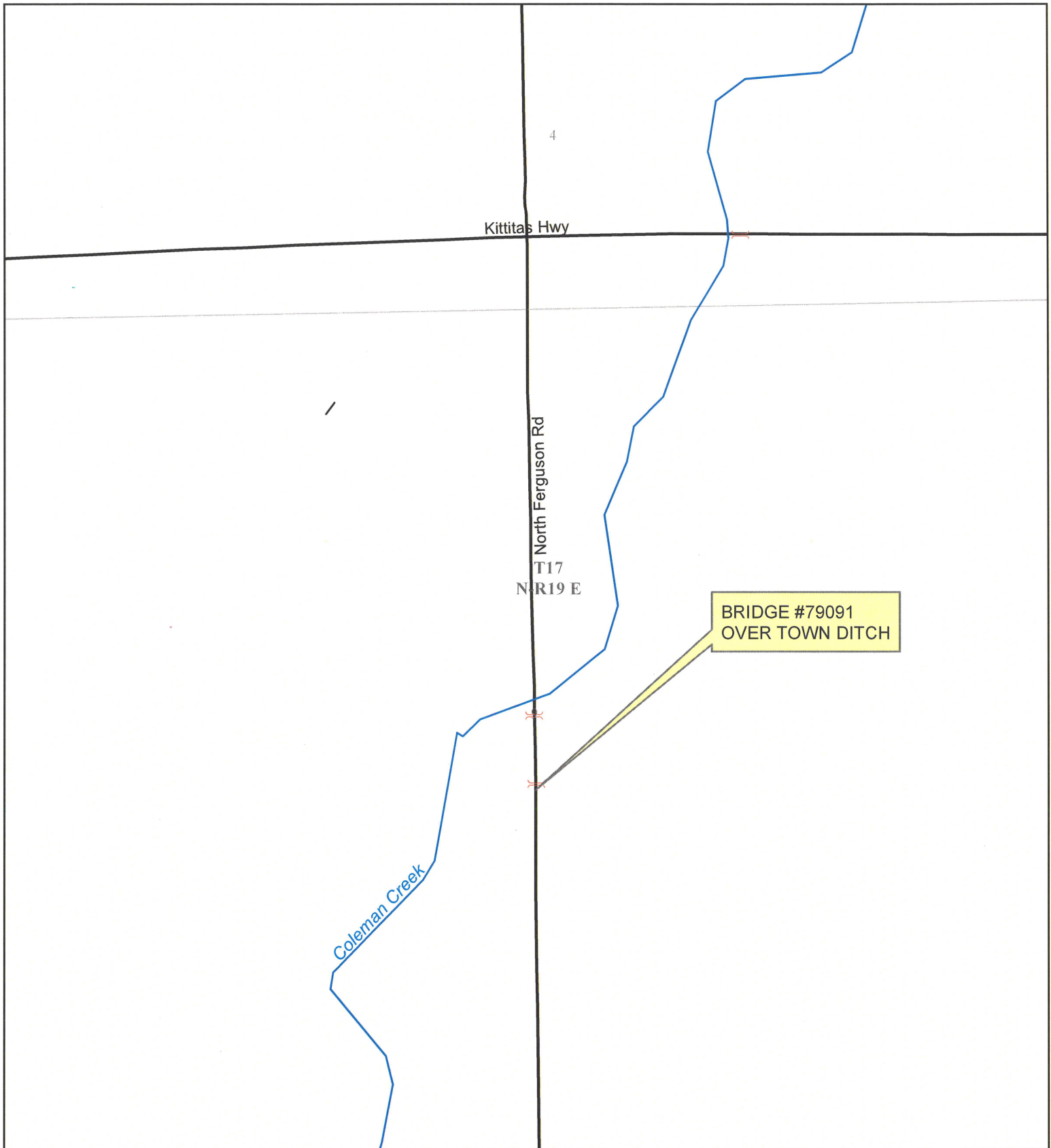
