# RESOLUTION AWARDING FUNDING FOR GRANTS PURSUANT TO LAW AND JUSTICE COUNCIL RECOMMENDATIONS ON SPENDING OF 1/10<sup>TH</sup> OF 1% SALES TAX RESERVES

WHEREAS: The Kittitas County Law and Justice Council met at their regularly

scheduled meeting on October 20, 2010, and voted unanimously for the

below described funding recommendations; and

WHEREAS: These expenditures shall be made from the 1/10<sup>th</sup> of 1% sales tax reserve

account established by the Board of County Commissioners for spending

on special projects to foster cooperation, sharing of resources and enhancement of criminal justice projects with Kittitas County; and

WHEREAS: Funding is to be made available January 1, 2011; and

WHEREAS: The amount authorized for 2011 grants is \$9,739.14. Current balance in

the grant funds is approximately \$50,000.00 with \$10,000.00 earmarked

for the approved 3/10<sup>th</sup> sales tax study, \$20,000.00 in reserve for

development of a firing range, and the balance for special Law and Justice

projects approved by the Board of County Commissioners.

WHEREAS: The Kittitas County Law and Justice Council and the Board of County

Commissioners have deemed these expenditures in the best interest of the

public.

NOW, THEREFORE BE IT RESOLVED: That the Kittitas County Board of Commissioners hereby adopts the following funding recommendations as made by the Kittitas County Law and Justice Council and these expenditures shall be made from the 1/10<sup>th</sup> of 1% sales tax reserve account.
