Resolution to Demonstrate the BOCC's support for a funding application to the Washington State Aviation Division for the Bowers Field Airport Master Plan Update and AGIS Survey and funding availability and Authorize the Director of Public Works to execute Airport Aid Application.

BACKGROUND:

The Federal Aviation Administration is requiring Kittitas County to prepare a Master Plan Update and AGIS Survey for Bowers Field Airport to support the planned extension of Runway 11/29 in 2018.

Funding for this project is comprised of WSDOT Aviation, Federal Aviation Administration, and Local dollars.

\$ 283,050 F.A.A. -WSDOT Aviation -\$ 15,750 Local Funds-\$ 15,750

WSDOT-Aviation requires that airports receiving funding must submit a resolution from their Board stating that they support the project and that funding has been budgeted for the local dollar match.

WHEREAS: The Airport Fund's portion of matching funds (5%) for this project will be \$15,750.00 which is in the Airport budget for 2015; and

NOW, THEREFORE BE IT RESOLVED the Kittitas County Board of County Commissioners declares it be in the best interest of Bower Field Airport, and does hereby support the funding request for the Bowers Field Airport Master Plan Update and authorize the Director of Public Works to execute the Airport Aid Application; and

BE IT FURTHER RESOLVED that the Kittitas County Board of County Commissioners have budgeted funds in the amount of \$15,750.00 to match Washington State Aviation funding for the project.
