- **WHEREAS:** The COG is presenting the results and their recommendations for the funding as shown in Exhibit 'A'; and;
- **WHEREAS:** The requested 2016 Sales and Use Tax Funding will be available on January 1, 2016.

**NOW, THEREFORE BE IT RESOLVED:** The Board of County Commissioners, after due consideration, does hereby accept the Conference of Government's recommendations to distribute the 2016 Sales and Use Tax for Public Facilities in Rural Counties in accordance with RCW 82.14.370 as shown in Exhibit 'A';

**NOW BE IT FURTHER RESOLVED:** The Public Works Department will manage the Public Facilities Account.
