Attached please find the second amendments to the two letters of credit extending their expiration dates to November 5, 2010. This additional time should be sufficient to allow the final refinancing documents, now being circulated, to be signed and the transaction closed and still leave more than 30 days prior to the expiration date of the letters. These amendments also provide for the immediate increase of one LC to \$5.5MM and reduction of the other to \$500,000 as per the settlement agreement. However, as I advised Neil earlier this week, the bank will require the county to approve the increase and decrease, respectively, as reflected on the documents and return them to the bank. Also as anticipated, these documents have been sent by the bank directly to the county—presumably to "Paul Bennett" at public works. Please have someone watch for them and let me know when they have arrived.

I will attend the commissioners' meeting Tuesday at which time I would ask that the county approve the changes. Although, I see no need to actually amend the settlement agreement so long as their expiration is more than 30 days hence, it is certainly appropriate for a status update. Thank you for your continued patience.
