Glen -- - To make the storage upgrade happen for Kittitas County, we would recommend the following - -

- Vicon to issue RA to return one (1) of the VN-SAN-42-1000 storage SAN arrays (42 TB total, 36 TB RAID5 useable) for a credit of \$28,309 against your PO # 14498. This unit needs to be returned to all original boxes and packing. ECS will pay for freight back to return unit back to Vicon.
- ECS to place a new Purchase Order for one (1) new VN-SAN-42-2000 storage SAN arrays (84 TB total, 68 TB RAID5 useable) at \$43,275. Shipping will be included at no cost.

Provide a cost to Increase the size of the video recording media to provide a minimum of 60 days recording of all cameras at 10 frames per second and 4 CIF quality. The initial contract required 30 days recording at 10 frames per second at 4 CIF. 32 TB useable storage with Raid 5 striping was specified in the contract. Increase the storage to 68 TB useable (84 TB raw) with raid 5 striping. Include all hardware and software and programming required to implement the additional recording time.
