IT IS HEREBY RESOLVED that Riverbottom Road/Jensen Levee elimination be improved as follows:


This project includes raising the elevation of Riverbottom by approximately 3 feet for levee protection from MP 0.40-1.00. This project will allow Public Works to better protect the road from flooding damages. Riverbottom Road levee will become protected under the USACE PL-84 program for flood protection. Jensen Levee will no longer be protected this program.

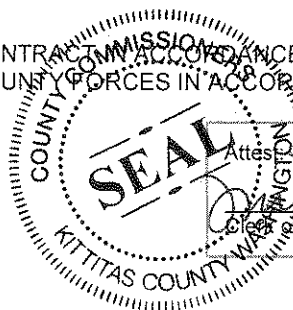
