BACKGROUND: Kittitas County Public Works received Sales &

Use Tax funds to reconstruct the Airport Industrial Park Roads. These include Elmview RD from mile post (MP) 0.00 to 0.39, Falcon RD from mile post (MP) 0.00 to 0.29, Beech RD from mile post (MP) 0.00 to 0.15, Cessna RD from mile post (MP) 0.00 to 0.15, and Piper RD from mile post (MP) 0.00 to 0.07. This construction will consist of installation of underground utilities including Sanitary Sewer, and Potable Water mains with services for these to county owned lots within the Bowers Field Airport Industrial Park project limits for

Phase 1 improvements.

Public Works coordinated with the local utilities and City of Ellensburg during design. Utility coordination will continue during construction.

This work also includes clearing and grubbing, excavation, backfill, compaction, utility structures and appurtenances, and other items associated with this work all in accordance with WSDOT Standard Specifications and Standard Plans, and City of Ellensburg Standards, project plans, and project specifications.
