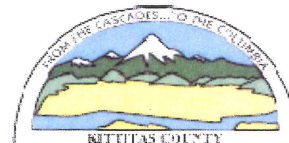

**PROFESSIONAL SERVICES AGREEMENT
BETWEEN KITTITAS COUNTY PUBLIC HEALTH AND KITTITAS COUNTY
COMMUNITY NETWORK COALITIONAMENDMENT**

The Professional Services Agreement Amendment between KITTITAS COUNTY ("County"), a subdivision of the State of Washington, and Kittitas County Community Network & Coalition ("Contractor"), to provide Youth for Truth program services attached hereto and incorporated by reference, is hereby amended to increase the total contract amount by \$750.00 making the new total contract amount \$2700.00. Printing materials increased from \$250.00 to \$375.00, presentation materials increased from \$250.00 to \$375.00, and space rental increased from \$250.00 to \$750.00. 
The amendment is mutually agreed to by the parties.
