CURRIER CREEK ESTATES 3 & 4

Dan Valoff, Staff Planner reviewed the Currier Creek Estates Division 3 & 4 Preliminary Plat (LP-10-02) application. He noted the Closed Record meeting had been continued from November 16, 2010. The request was from Steve Lathrop, Agent for Cascade View Inc. property owner, for a preliminary plat subdivision of approximately 24.28 acres into 88 single-family residential lots. He indicated it would be completed in two phases: Phase 3 (13.17 acres) would develop 49 lots, and Phase 4 (11.11) acres would develop 39 lots. The property is located northeast of Hwy 10, southwest of Dry Creek Road and Reecer Creek Road, within the City of Ellensburg's Urban Growth Area (Map Numbers 18-18-27030-0036 and 18-18-27030-0037). He noted the Board had asked to amend Condition #14 regarding Road Ownership.

Commissioner Jewell moved to approve the Hearing Examiners recommended Conditions with the modification to Item 14; the Findings of Fact and direct staff to prepare enabling documents. Commissioner Crankovich seconded. Motion carried 3-0.

## CLOSED RECORD MEETING

## AIRPORT HEIGHTS PLAT

CDS

Dan Valoff, Staff Planner reviewed the Airport Heights Preliminary Plat (LP-09-08) application. He noted the Closed Record meeting had been continued from November 16, 2010. The request was from Terra Design Group, authorized agent for Schuler Deneen Family Ranch LLC, James K. Schuler, care of Pat Deneen PDQ Construction, landowners, for a Preliminary Plat to subdivide approximately 34.29 acres into 10-lots, which would be 3 acres in size. He noted there would be an area south of these lots that would be considered as Tract A that would be 3.69 acres

in size for the possible future expansion of the Cle Elum Municipal Airport. The subject property is currently zoned Ag-3 and is to be served by a Group A Public Water System and individual or possibly a community septic areas if soils permit. The subject property is located east of the City of Cle Elum, north of Airport Road, off Danko Road, Cle Elum, WA (Map Numbers 20-16-30030-0004, 0008, 0009 and 20-16-30056-0016).

Commissioner Jewell moved to approve the Airport Heights Preliminary Plat (LP-09-08), adopt the Hearing Examiners recommended Conditions, Findings of Fact and direct staff to prepare enabling documents. Commissioner Crankovich seconded.

Commissioner Crankovich said he had reviewed all the recommended conditions proposed by the Hearing Examiner and felt they were accurate however there was one item in the record from the City of Cle Elum objecting to the proposal. He said they felt if the application was approved, there could be a potential impact to the municipal airport and may have long lasting effects. He explained that in the past, the Board has given weight from comments from municipalities which have a direct impact.

Commissioner Jewell said he had also looked at the proposal very closely. He appreciated Commissioner Crankovich's concerns, but when he went through the record most of the concerns were dealt with in the proposed conditions of approval. He said he understood the City's concerns, but with the work going on with the overlay project, it may help. The underlying zoning is consistent with the proposal and mitigations are included and the application should be approved.

Motion carried 2-1 (Commissioner Crankovich opposed).

He felt everyone came together more this year than in years past and although there were some difficult decisions made, the County is not being faced with a reduction in work force. Commissioner Crankovich expressed his appreciation to everyone for their efforts as well. Chairman McClain thanked Judy Pless for four years of work and felt it was a positive step by having everyone in the room including the Unions. He felt there were places that could still be cut, and is not convinced that the County hadn't delayed decisions regarding a reduction in work force.

Motion carried 2-1 (Chairman McClain opposed).

## PUBLIC HEARING DISSOLUTION TV IMPROVEMENT DIST. & BOARD COMMISSIONERS

At 10:28 a.m. Chairman McClain opened the public hearing continued from November 2, 1010 to consider dissolving the Kittitas County TV Reception Improvement District & Board, noting the record was closed.

Jim Mapes, Board member of the TV Improvement District, said he had given the inventory to Suzanne Becker, Deputy Prosecutor, and has a letter from Jack Eaton. Neil Caulkins, Deputy Prosecutor, noted Mr. Eaton's letter said he was only fine with transferring the broadcast license. He explained Mr. Eaton needs to transfer the "lease". Mr. Mapes said he would have Ms. Becker send a complete list of what needs to be done in order to proceed with the dissolution of the TV Improvement District and Board. He asked for guidance because there were bills that need to be paid, but there are not enough members to have a quorum to make those decisions. The Board asked that Ms. Becker work with him to see if there is a way for him to bring the bills forward so the Board of County Commissioners could approve payment of those.

Commissioner Jewell moved to continue the public hearing to Tuesday December 21, 2010 at 10:00 a.m. in the Commissioners Auditorium, Room 109, Kittitas County Courthouse 205 West  $5^{\rm th}$  Avenue Ellensburg, WA noting the record is closed. Commissioner Crankovich seconded. Motion carried 3-0.
