This Treatment Agreement between Kittitas County and Alcohol Drug Dependency Services is here by amended as follows:

1. Change Section 9.c., to read as follows:

Prioritized Patient Categories

In accordance with SAPT Block Grant requirements, the County shall provide services under this Agreement giving preference as follows:

- (1) Pregnant injecting drug users
- (2) Pregnant substance abusers
- (3) Injecting drug users
- (4) Washington State defined priority populations; subsections (b) through (f) are in no particular order:
 - (a) Parenting women (first priority)
 - (b) Postpartum (up to one year, regardless of pregnancy outcome)
 - (c) Parenting individuals involved with Child Protective Services
 - (d) Youth
 - (e) Offenders (as defined in RCW 70.96A.350)
 - (f) Other Medicaid Clients
- (5) All others

2. Remove Section 9.g. (2) (b) in its entirety.

3. Remove Section 9.g. (4) (b) in its entirety.

4. The Specific Eligibility and/or Funding Requirements section is amended as follows:

A new subsection c. is added:

c. Funding limitations for services to persons who are incarcerated:

- (1) Medicaid funds: Medicaid funds shall not be used to provide services of any kind to persons incarcerated in a correctional setting, including but not limited to any correctional facility owned or operated by the state, county, or city.
- (2) State Grant-in-Aid and CJTA funds: Assessment services are the only services allowed to persons incarcerated.

5. Under Consideration, a new Subsection e. (4), is added to the County Participation Match Requirement as follows:

Local Cost Sharing Agreement: Counties shall submit a completed Local Cost Sharing Agreement, along with the June monthly A19 Invoice Voucher, to their Regional Administrator annually.

6. Section 21, TARGET Requirements, Subsection d. (1) is changed to read as follows: Ensure that the date of first contact is entered into TARGET at least every seven (7) days.
7. The maximum consideration is decreased by \$7,376.35 to \$623,725.65. Funding changes in the following categories are identified on the new A&R, Exhibit A, attached:
