

ADDENDUM #5 TO LICENSE AGREEMENT

BETWEEN KITTITAS COUNTY AND BALANCED ACTION, INC.

Addendum to the current License Agreement, made and entered into between Kittitas County, hereinafter called County, and Balanced Action, Inc., hereinafter called Vendor. The parties to the Agreement agree to amend said Agreement as follows:

County will purchase an additional module to add REET Excise.functions to the Cashtax core package. This module will allow the following enhanced functionality:

Management of excise transactions, including auto calculation of fees and electronic export of documents to Washington State Department of Revenue (DOR). Excise transaction data will be available for linkage to property tax module to facilitate changes of ownership, property classification, exemption status, and other events that originate as excise transactions but affect the attributes of the property account. This will allow a single point of entry and eliminate redundant effort currently experienced by the Treasurer's Office. Electronic export of data to other County Offices (i.e. Assessor's Office) will similarly be supported.


