

ORDINANCE NO. 4577

AN ORDINANCE of the City of Ellensburg, Washington, levying taxes for municipal purposes of the City of Ellensburg, Washington, for the year 2011 according to the assessed valuation as determined in the year 2010 in accordance with RCW 84.55.120.

WHEREAS, the City Council of the City of Ellensburg has met and considered its budget for calendar year 2011; and,

WHEREAS, the City's actual levy amount from previous year was \$2,420,999.14; and,


WHEREAS, the latest Implicit Price Deflector (IPD) is 1.539%; and

WHEREAS, the population of the city is more than 10,000; and

NOW THEREFORE, BE IT RESOLVED, by the governing body of the City of Ellensburg that there is an increase in the regular property tax levy to be collected in the 2011 tax year.

The dollar amount of the increase over the actual levy amount from previous year shall be \$24,209.99 which is a percentage increase of 1% from previous year plus 0.322% banked levy capacity (\$7,800). This increase is exclusive of additional revenue resulting from new construction, improvements to property, any increase in the value of state assessed property, any annexations that have occurred and refunds made. The amount of \$264,375 out of this levy is dedicated to Fire Relief & Pension Fund in accordance with RCW 84.52.043.
