

# Kittitas County Fire Protection District 6

## Resolution 2010-6

WHEREAS the Board of Fire Commissioners of Kittitas County Fire Protection District 6 has properly held a public hearing held November 3, 2010 to consider the Kittitas County Fire District 6 current expense budget for the 2011 calendar year, pursuant to RCW 84.55.120; and

WHEREAS the Board of Fire Commissioners of Kittitas County Fire Protection District 6, after hearing, and after duly considering all relevant evidence and testimony presented, determined that Kittitas County Fire Protection District 6 requires an increase in property tax revenue from the previous year, in addition to that resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, in order to discharge the expected expenses and obligations of the district and in its best interest; now therefore

BE IT RESOLVED, by the Board of Fire Commissioners of Kittitas County Fire Protection District 6 that an increase in the regular property tax levy is hereby authorized for the 2011 levy in the amount of \$ 1,306.73 which is a percentage increase of 1% from the previous year. In addition Kittitas County Fire Protection District 6 will levy up to 3.38 % of banked levy capacity.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.
