AGREEMENT RATIFYING AND CONFIRMING DEVELOPMENT AGREEMENT BY AND BETWEEN KITTITAS COUNTY, WASHINGTON, SUNCADIA LLC, AND NEW SUNCADIA, LLC

THIS AGREEMENT RATIFYING AND CONFIRMING DEVELOPMENT AGREEMENT ("Agreement") is entered into as of the 19^{-4} day of July, 2012, by and between SUNCADIA LLC, a Delaware Limited Liability Company registered to conduct business in the state of Washington ("Suncadia"), NEW SUNCADIA, LLC, a Delaware Limited Liability Company registered to conduct business in the state of Washington ("New Suncadia") and KITTITAS COUNTY, a Washington municipal corporation (the "County").

RECITALS

A. The County and Suncadia's predecessors in interest previously entered into that certain Development Agreement dated October 10, 2000, together with all underlying documents and as amended, (collectively the "Development Agreement").

B. Suncadia requested and received the County's consent to the transfer of Suncadia's property, entitlements, obligations, covenants and conditions under the Development Agreement, including, but not limited to the MPR approvals and the subsequent actions, as those terms are defined in the Development Agreement, (collectively the "Transfer") to New Suncadia, subject to the terms and conditions of Resolution 2012-032, dated March 30, 2012.

C. The Transfer was consummated on or about June $\underline{\mathscr{B}}$, 2012, and the parties desire to comply with the provisions of Resolution 2012-032 by having New Suncadia ratify and assume all entitlements, obligations, covenants and conditions of Suncadia contained in the Development Agreement, all as set forth herein.

NOW, THEREFORE, in consideration of the forgoing and the mutual covenants, entitlements, and obligations, all as set forth in the Development, the parties hereto hereby agree as follows:

1. New Suncadia ratifies, assumes, confirms and agrees to be bound by the terms and conditions of the Development Agreement the same as an original signatory thereto.

2. The County confirms and agrees that, effective upon the Transfer, New Suncadia shall be fully and concurrently vested with and entitled to all rights and entitlements running to the benefit of Suncadia as set forth in the Development Agreement.

3. Suncadia confirms that it is not presently seeking to be released from any of its entitlements, obligations, covenants and conditions under the Development Agreement.
