**FINANCE MEETING**

**AUDITOR**

At 1:30 p.m. **Vice-Chairman Jewell** opened the regular finance meeting. **Judy Pless** presented the sales tax information through November 2010. Collections through November were \$2,412,326.26; 92.78% of the adopted budget of \$2,600,000. The board received a preliminary report of the November 2010 expense and revenues.

**Ms. Pless** requested to pursue looking into having the Board of County Commissioners review and sign Personal Action Forms (PAF's) and Budget Amendment forms electronically. The Board approved Ms. Pless to start the process.

**Ms. Pless** also informed the Board that the Auditor's Office wanted to complete the Comprehensive Annual Financial Report by April 30, 2011 instead of May 30, 2011 and will be requesting information from all departments in a timely manner.

**JAIL FAN REPLACEMENT & CLEANING**

**SHERIFF**

**Patti Johnson** informed the Board that exhaust fans need to be replaced on the existing jail. Contractor Holmberg has in their contract to complete the air balancing and chemically clean the chilled water system in the existing fans. **Ms. Johnson** recommend to the Board that Holmberg does not do this process with the fans resulting in a \$10,500.00 credit; and contract with Kollmar, Inc to install 4 (four) new Exhaust fans, including the electrical, controls and air balance and commissioning for a total cost of \$40,450.34; and to clean the existing coils in the amount of \$20,645.24. The budget for the project was \$1.5 million and the current project is estimated \$1.3 million. **Commissioner Crankovich** moved to approve Ms Johnson to have the exhaust system fixed. **Vice-**
