RESOLUTION NO. 2017-<u>00</u>3

A RESOLUTION AMENDING THE SERVICE FEES BY COMMUNITY DEVELOPMENT SERVICES CHARGED FOR BUILDING AND LAND USE SERVICES

- WHEREAS, Kittitas County Code 4.10.010 authorizes Community Development Services fees to be set by resolution approved by the Board of County Commissioners; and
- WHEREAS, In 2014, the County contracted the services of FCS Group to determine adequate fees to cover the cost of services provided to process a land use or building permit; and
- WHEREAS, In 2015, the consultant monitored activities of personnel when processing the permits and made a determination of the actual cost for providing the service to process land use and building permits; and
- WHEREAS, The consultant developed a fee model for Planning Services and Building Fixture permits that calculated the amount of direct and indirect costs associated with each development activity; and
- WHEREAS, The consultant also developed a fee multiplier model for new construction designed to determine a construction fee which could be adjusted based upon the amount of new construction activity occurring in a single year; and
- WHERAS, The Board of County Commissioners adopted Resolution 2015-151 on November 17, 2015, requiring that fees charged by Community Development Services for land use and building permit services be re-evaluated annually for consideration and adjustment by the Board of County Commissioners for each fiscal year; and
- WHEREAS, The Board of County Commissioners on January 17, 2017 set a date for public hearing to hear comments and consider potential Community Development Services fee changes; and
- WHEREAS, Public notice for such a hearing was provided in the Daily Record on January 19, 2017 and January 26, 2017; and


- WHEREAS, The Board of County Commissioners conducted a public hearing to consider the Community Development Services Fee Schedule on February 7, 2017, which was continued to February 21, 2017, March 7, 2017, and March 21, 2017; and
- WHEREAS, Community Development Services staff recommended fees to the Board of County Commissioners at the public hearing based on the consultant's fee models for full cost recovery to provide the building and land use services; and
- WHEREAS, At the February 7, 2017 and March 21, 2017 public hearing, public testimony regarding the proposed fees was received by the Board of County Commissioners; and
- WHEREAS, At the March 21, 2017 public hearing the Board of County Commissioners continued the hearing until April 4, 2017 for discussion and decision with the public record remaining open for public comment until March 31, 2017.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED, that the following fees are adopted for Community Development Services in Kittitas County and effective on April 10, 2017:

- 1. Fees for Building Fixtures and Planning Services as shown in the attached Exhibit A.
- 2. August 2016 Building Valuation Data table of the International Building Safety Journal for the purposes of calculating fees for new construction.
- 3. A multiplier for building permits for new construction of .010.
- 4. A five percent (5%) technology and equipment surcharge for building permits to cover cost of repair and replacement of vehicles and equipment used to process the permits; and

BE IT FURTHER RESOLVED AND HEREBY ORDERED, that service monitoring be continued, and that fees charged by CDS for land use and building permit services be re-evaluated annually based upon such monitoring for consideration and adjustment by the Board of County Commissioners for each fiscal year.
