**TO RATIFY KITTITAS VALLEY EVENT CENTER RATE STRUCTURE and
KITTITAS COUNTY FAIR FEES**

WHEREAS: The Facilities Director of the Kittitas Valley Event Center has the authority to establish the various rates, policies, and procedures governing the use of the Kittitas Valley Event Center, and Kittitas County Fair, and

WHEREAS: the people of Kittitas County benefit by having available to them a published rate structure for the use of certain facilities located at the Kittitas Valley Event Center as well as fees for the Kittitas County Fair and,

WHEREAS: the Kittitas County Board of County Commissioners has the authority to establish or affirm such rate structures by resolution and,

WHEREAS: a rate structure that is established by resolution protects the public from preferential or arbitrary pricing,

WHEREAS: a rate/fee structure is currently in place for the Kittitas Valley Event Center and Kittitas County Fair,


