**RESOLUTION TO RESCIND RESOLUTION 2010-25 THAT AWARDED THE BID TO
FURNISH ASPHALT MATERIALS FOR 2010**

- WHEREAS: A Notice of Call for Bids was approved and signed on February 2, 2010, to furnish Asphalt Materials for 2010; and
- WHEREAS: Sealed bids were opened on February 17, 2010, at 2:00 p.m. in the Kittitas County Public Works and three (3) bids were received; and
- WHEREAS: The Public Works Department recommended that the lowest responsible bid from Granite Northwest, Inc. be accepted for Schedule "A" in the amounts of Class "G" Asphalt being \$59.75/Ton and Class "B" Asphalt being \$59.75/Ton and the lowest responsible bid from Columbia Ready Mix Inc. be accepted for Schedule "B" Cold Mix in the amount of \$115.00/Ton; and
- WHEREAS: It was discovered that the bid submitted by Granite Northwest, Inc. did not include delivery within 15 miles of the Lower County Shop, therefore is deemed to be unresponsive to the bid specifications; and
- WHEREAS: Granite Northwest, Inc. acted in good faith when providing their bid, and did not act with gross negligence when providing the bid amount. Granite Northwest, Inc. was reasonably prompt in giving notice of the bid information that differed from what Kittitas County Public Works specified; and
- WHEREAS: Granite Northwest, Inc. and Kittitas County are agreeable in the withdrawal of the bid and neither will have substantial hardship by the withdrawal. The status of Kittitas County has not greatly changed because of the withdrawal; and
- WHEREAS: Public Works is recommending the next lowest responsible bid of Columbia Ready Mix, Inc. be accepted for Schedule "A" in the amounts of Class "G" Asphalt being \$61.00/Ton and Class "B" Asphalt being \$61.00/Ton as well as Schedule "B" Cold Mix in the amount of \$115.00/Ton.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners, in the best interest of the public, does hereby allow Granite Northwest, Inc. to withdraw its bid to furnish asphalt materials for 2010 and does hereby rescind Resolution 2010-25.

BE IT FURTHER RESOLVED that the Board of County Commissioners does hereby award the bid for 2010 Asphalt Materials Schedule "A" and Schedule "B" to the next lowest responsible bidder, Columbia Ready Mix Inc, upon such terms and conditions as specified in the Proposal submitted by said bidder(s).

BE IT FURTHER RESOLVED that the Director of Public Works is authorized to sign the contract documents upon such terms and conditions specified in the Proposal submitted by said bidder(s).
