5 RESOLUTION CREATING A SPECIAL REVENUE FUND FOR THE ADULT
6 MISDEMEANOR PRE-CHARGING DIVERSION PROGRAM

8 WHEREAS, the Kittitas County Prosecuting Attorney has in coordination with local law
9 enforcement and Kittitas County Misdemeanant Probation created an Adult Misdemeanor Pre-
10 charging Diversion Program, and

11 WHEREAS, individuals that wish to take advantage of this program are required to make
12 contributions to cover the administrative expenses of the program and to benefit the community
13 by increasing enforcement of the laws and education regarding illegal drug and alcohol use, and
14 NOW, THEREFORE,

15 IT IS HEREBY RESOLVED that:
16

- 17 1. A special revenue fund, Fund 136 is established and may be otherwise referred to as
18 the Adult Misdemeanor Pre-charging Diversion Fund.
19 2. There shall be deposited to the Adult Misdemeanor Pre-charging Diversion Fund
20 such money as may be transferred thereto by order of the Board of County
21 Commissioners together with such other money as shall be collected through the
22 Adult Misdemeanor Pre-charging Diversion Program.

1 3. Funds shall be disbursed from the fund as authorized by the Kittitas County

2 Prosecuting Attorney's Office:

3 A. To cover the costs of administering the Adult Misdemeanor Pre-charging
4 Diversion Program, including but not limited to costs incurred by
5 Misdemeanant Probation to supervise the participants and the Prosecutor's
6 Office for administration of the Program, and such administrative costs
7 collected shall be disbursed to the Misdemeanant Probation and to the general
8 fund respectively,

9 B. Funds collected or deposited, other than probation costs and Prosecuting
10 Attorney Administrative costs may be disbursed to a public benefit nonprofit
11 corporations pursuant to an agreement that those funds be used for a law
12 enforcement and/or educational purpose related to illegal use of drugs
13 including alcohol.

14 C. Funds collected or deposited, other than probation costs and Prosecuting
15 Attorney Administrative costs may be disbursed from the fund as authorized
16 by the Kittitas County Prosecuting Attorney for any other lawful purpose that
17 is aimed at increasing enforcement of the laws of the State of Washington and
18 education regarding illegal drug and alcohol use.

20 4. Any balance in said fund at the end of a budget year shall not lapse nor shall the same
21 be a surplus which may be used for any purpose other than herein specified, except as
22 provided by law.



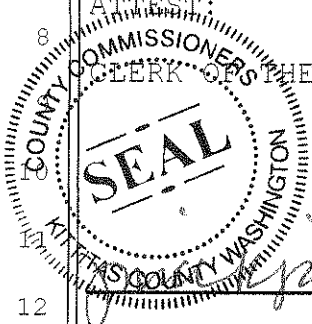
