**WHEREAS,** In prosecuting the appeal, it was necessary to obtain a transcript of proceeding and certified copy of the administrative record; and,

**WHEREAS,** The transcript cost \$1004 and the certified record cost \$45.38; and,

**NOW, THEREFORE BE IT RESOLVED:**

1. The Kittitas County Board of County Commissioners hereby approves entering payment of the costs related to prosecuting its appeal of the Hearings Board's decision related to the Thorp Travel Center.
