



AMENDMENT NO. 1

TO

CONTRACT C1600097

BETWEEN THE

STATE OF WASHINGTON DEPARTMENT OF ECOLOGY

AND

KITTITAS COUNTY BOARD OF COMMISSIONERS

PURPOSE: To amend the Agreement between the state of Washington, Department of Ecology, hereinafter referred to as "ECOLOGY," and Kittitas County Board of Commissioners, hereinafter referred to as "*KITTITAS*."

IT IS MUTUALLY AGREED the Agreement is amended as follows:

- 1) The Period of Performance is amended to read as follows: The period of performance is extended from June 30, 2017 to June 30, 2018.
- 2) The Budget is amended to read as follows: Total compensation is increased by \$250,000.00 from \$500,000.00 to a new contract value of \$750,000.00.
- 3) The Scope of Work is amended to read as follows:

Task 1: Purchase Mitigation Water and Metering Equipment

- 1.1 Purchase pre-1905 senior water rights for mitigation water that will be used for new and current domestic uses of groundwater. KITTITAS will consult with Ecology for approval on costs before entering into any purchase and sale agreement under this agreement. Failing to comply with this requirement to consult with ECOLOGY will result in a denial of the reimbursement request under this agreement.

Deliverables:

Status report of water acquired, due December 31, 2017.

Water purchase and sale agreements, due June 30, 2018.
