

This treatment Agreement between Kittitas County and Cascade Recovery Resource Center (CRRC) is here by amended as follows:

1. To adjust for final utilization of funds the total of FY 11 State Grant-in-Aid funding has been decreased by \$2,577.96. State GIA for Direct Billing is decreased by \$377.96 and State GIA – T19 Match has been reduced by \$2,200.00.
2. The maximum consideration for the entire contract is decreased by \$2,577.96 to \$61,300.39. All funding changes described above are identified on the attached A&R, Exhibit A.

All other terms and conditions of this Contract remain in full force and effect.
