PROJECT DESCRIPTION

The work to be performed by the CONSULTANT consists of preparing preliminary engineering design for some improvements to Kittitas Highway. The proposed improvements include adding bicycle lanes, increasing intersection radii, increasing left turn storage, removal and replacement of bridges, adding parking lanes for law enforcement, grinding and overlaying the existing roadway and construction of retaining walls to provide for roadway widening. The major features of the project are as follows:

- Approximately 4.5 miles of widening for two bicycle lanes.
- Improving intersection radii to meet design standards.
- Increasing left turn storage.
- Environmental planning and preparation of permit applications.
- Structural design for retaining walls, bridges and culvert extensions/replacements.
