


DESCRIPTION/JUSTIFICATION OF AMENDMENT: <b>The contract provides financial assistance to the County solely for the expenses necessary to answer 911 calls originating in the county, which includes performing certain tasks and maintaining certain equipment necessary to operate Wireline and Wireless Enhanced 911. Reimbursement shall be solely for eligible items included in Chapter 118-66 WAC. The original contract Budget sheet was based on estimated expenditures. This amendment is necessary to adjust the funding in the Budget sheet (Exhibit C) based on final expenditures.</b>			
11. AMENDMENT TERMS AND CONDITIONS: <div style="margin-left: 20px;"><p>1. Contract expiration date of September 30, 2010 remains <b>unchanged</b>.</p><p>2. <b>Change</b> the overall contract amount from \$336,356 to \$341,044.89; an increase of \$4,688.89.</p><p>3. In the Budget Sheet, Exhibit C, State Reimbursable column, <b>make</b> the following <b>changes</b>:</p><div style="margin-left: 20px;"><p>a. Wireline remains <b>unchanged</b>.</p><p>b. Wireless <b>change</b> from \$183,814 to \$188,502.89; an increase of \$4,688.89.</p></div></div>			
This Amendment is incorporated in and made a part of the contract. Except as amended herein, all other terms and conditions of the contract remain in full force and effect. Any reference in the original contract or an Amendment to the "contract" shall mean "contract as amended". The Department and Contractor acknowledge and accept the terms of this Amendment as identified above, effective on the final date of execution below.
