Mr. Plouse signed the King County Registration Requirement Document July 14, 1995

Mr. Plouse was ordered to 20 months confinement count 1 and 20 months confinement count 2, commencing August 25, 1995.

Mr. Plouse arrived in Kittitas County and registered October 5, 2004 providing the address of 271 Baker Lane, Easton.

Mr. Plouse RSO Status was verified through NCIC by Det. Higashiyama November 2, 2006

Mr. Plouse submitted a signed Registered Sex Offender address verification Letter to the Sheriff's Office March 28, 2007, Certifying under penalty of perjury he was residing at 271 Baker Lane, Easton.

Mr. Plouse submitted a signed Registered Sex Offender address verification Letter to the Sheriff's Office July 8, 2008, Certifying under penalty of perjury he was residing at 271 Baker Lane, Easton.

Mr. Plouse submitted a signed Registered Sex Offender address verification Letter to the Sheriff's Office March 13, 2009, Certifying under penalty of perjury he was residing at 271 Baker Lane, Easton.

Detective Severson conducted a on-site address verification June 1, 2009 at 271 Baker Lane, Easton. He found the remnants of a home long destroyed by fire. There were no other tents, campers, huts or dwellings on the property, nor was there signs of rebuilding.

Detective Severson re-visited the property located at 271 Baker Lane June 18, 2009 and found it in the same condition. Review of local records found the fire had not been reported. Det. Severson left messages on the phone numbers provided by Mr. Plouse, none of which were returned. He also attempted to find forwarding address information through the Easton Post Office.

RCW 9A.44.142 allows a person required to register as a sex offender to, 'Petition the Superior Court' for relief from duty to register.

RCW 9A.44.141 allows a person required to register as a sex offender to, 'Request the County Sheriff' investigate the person's qualification to be relieved from his/her duty to register.

The Sheriff's Office received no request from Mr. Plouse to investigate or relieve him from his duty to register until May 21, 2010. Mr. Plouse's unlawful declarations support that he made no such requests and knew he was still bound by law to register.

Detective Severson submitted a, prosecutor approved affidavit, and an arrest warrant was issued by the court for Mr. Plouse for failure to register.

August 14, 2009 Mr. Plouse was arrested.

August 17, 2009 Mr. Plouse was released on Bail.

August 20, 2009 Mr. Plouse submitted a Registered Sex Offender Change of Address Form listing his old address as 271 Baker Lane and his new address as 450 1st Street in Easton.

May 21, 2010 James Kirkham of the Kirkham Law Office submitted a request to have Mr. Plouse removed from his duty to register,

As of May 19, 2011 no applications for building permits have been submitted by Mr. Plouse, or anyone else, for the property located at 271 Baker Lane in Easton. This and the Detective's observations of the property are in contrast of the claim that Mr. Plouse was, "building a new cabin" on the property.

The Sheriff's Staff acted in good faith and under color of law and we recommend denial of the claim.
