This Treatment Agreement between Kittitas County and Alcohol Drug Dependency Services is here by amended as follows:

1. Due to underutilization by CRRC, FY 11 State Grant-in-Aid funding has been increased by \$2,577.96. State GIA for Direct Billing is increased by \$8,000.00 and State GIA – Title 19 Match has been increased by \$5,000.00.
2. The maximum consideration for the entire contract has been increased by \$2,577.96 to \$639,303.61. All funding changes described above are identified on the attached A&R, Exhibit A.

All other terms and conditions of this Contract remain in full force and effect.
