1. Demonstrated history of at least three years of successfully providing employment and day services for people with developmental disabilities in community-based settings.

Elmview has provided employment services for people with developmental disabilities for more than 30 years. Services have been provided through a contract with Kittitas County. Elmview currently provides services through a contract with the County that runs through June 30, 2011. Services are provided primarily in three categories:

<u>Community Access</u>—Community Access services are individualized services provided in typical integrated community settings for individuals in retirement. Services will promote the persons' competence, integration, physical or mental abilities. Services assist individuals to participate in activities, events and organizations in the community in ways similar to others of similar age. These services may also be available for working age individuals for whom an Exception to Rule has been approved.



• Group Supported Employment—Group Supported Employment services are a part of an individual's pathway to integrated jobs in typical community employment. These services include many of the elements described in Individual Supported Employment and offer ongoing supervised employment for groups of no more than eight (8) workers with disabilities in the same setting. Examples include enclaves, mobile crews, and other business models employing small groups of workers with disabilities in integrated employment in community settings.

These are one-to-one services necessary to help persons with developmental disabilities obtain and continue integrated employment at or above the state's minimum wage in the general workforce. These services may include intake, discovery, assessment, job preparation, job marketing, job supports, record keeping and support to maintain a job.



 Demonstrated history of at least three years of successfully providing employment and day services for people with developmental disabilities in community-based settings.

Entrust has more than 40 years of successful of experience serving people with developmental disabilities in facility and community-based settings throughout Kittitas, Yakima, Franklin and Benton counties. In 2009, 87 people were hired into independent community jobs and 133 worked in our job training program earning more than \$190,000 in wages. Through Project Rise (Realizing independence through Self-Employment) Entrust helped 35 people pursue self-employment.

Entrust also provides an Adult Day Health program which includes physical, occupational and speech therapy. Skilled nursing services and structured therapeutic activities are provided so participants may increase their level of functioning and delay further deterioration. Therapy results in significant improvement and well-being of our participants, allowing them to lead more independent and productive lives.
