

WHEREAS, the City Council of the City of Ellensburg has met and considered amending the tax amount certified to the Kittitas County legislative authority ; and,

WHEREAS, the City previously certified to the Kittitas County legislative authority with Ordinance 4603; and

NOW THEREFORE, BE IT RESOLVED, by the governing body of the City of Ellensburg that Ordinance No. 4603 certifying the property tax levy to be collected in 2012 is now repealed.


Regular Levy: \$2,550,000


