ACTION REQUESTED:

Ordinance approving the Tamarack Valley Rezone (Z-10-04) and Preliminary Plat (LP-10-03).

BACKGROUND:

Brookside Consulting, agent for the property owner Cooper Pass LLC, submitted an application for a rezone from Forest and Range to Rural-3 along with a Preliminary Plat to subdivide approximately 18.5 acres into 6-lots.

The property is located north of Misty Mountain Way and south of Storie Lane, Cle Elum, WA in a portion of Section 28, T20N, R14E, WM, in Kittitas County. Assessor's map number: 20-14-28000-0007.

The Hearing Examiner conducted an open record hearing on May 26, 2011 to consider this matter where testimony was heard. On June 8, 2011 the Hearing Examiner issued a recommendation subject to conditions for the Tamarack Valley Rezone (Z-10-04) and Preliminary Plat (LP-10-03).

On August 16, 2011 the Board of County Commissioner's conducted a closed record meeting to consider the Hearing Examiner's recommendation on the Vista West Performance Based Cluster Plat (CL-09-01), the Tamarack Valley Rezone (RZ-10-04) and Preliminary Plat (LP-10-03) and the Aspen Grove Preliminary Plat (LP-10-04). The Board came to the consensus to discuss the three applications together since there seemed to the same issues surrounding them all.

It was moved and seconded to remand the three applications back to the Hearing Examiner to conduct an open record hearing to consider 1) cumulative impacts from the three applications before making his decision, 2) the total combined number of lots, 3) the Long Range Transportation Plan, 4) secondary access, and, 5) the requirements of the International Fire Code.

The Hearing Examiner conducted an open record hearing on October 27, 2011 to consider the remand issues where testimony was heard. On November 10, 2011 the Hearing Examiner issued a recommendation of approval subject to conditions for the Tamarack Valley Rezone (Z-10-04) and Preliminary Plat (LP-10-03).

The Board of County Commissioner's conducted a closed record meeting on December 22, 2011 for the purpose of consideration of the Hearing Examiner's recommendation on the Tamarack Valley Rezone (Z-10-04) and Preliminary Plat (LP-10-03). A motion was made and seconded that the preliminary plat be approved, the motion carried with a vote of 3 to 0.

INTERACTION:

Prosecutor's Office has reviewed the ordinance.

RECOMMENDATION:

Staff recommends that the Board sign the ordinance.
