Purpose: To amend the above referenced grant agreement between the Department of Ecology (Department) and Kittitas County Public Health (Recipient). This amendment will allow the recipient to receive reimbursement for activities within the scope of work through June 30, 2011.

IT IS MUTUALLY AGREED that the agreement is amended as follows:

1. The total maximum eligible cost for this agreement increases by \$20,777 from \$77,535 to \$98,312. The state share amount for this agreement increases by \$15,583 from \$58,151 to \$73,734.
2. The following table outlines the changes to the budget listed by task.
